The minutes of the July 14, 2021 meeting were approved as read.

The treasurer's report - As of July 31, 2021 the treasurer reported the following: **Income:** \$5.00 (interest), \$125 (Kitchen/pavilion), and Expenses: \$40 (water tests).

More research is needed concerning this request, **reseeding** the Mexico field – the field is being fertilized in the spring and fall to promote more grass growth. 2) **Cracker dust to bleachers, track and power box areas** – a work detail is necessary to do this with everyone helping. 3) **Fill low areas in parking lot** – Marty will ask the Supervisors to fill in the areas when they get down that way. 4) **Scoreboard repair** – Tiffany reported, again, that this is the Mexico Youth Baseball's responsibility. 5) **Rails missing on the playground fence** – Mr. Yorks was asked how many rails were in storage – he did not know, possibly 1. Marty and Paul will look into this. 6) **Playground picnic table need seat boards replaced** – Paul and Marty will look into this. 7) **Fertilizer spread onto track, pavilions and dugouts** – There is no way to stop this without spreading individual areas which is too time consuming. 8) **Have someone spray weed for weeds in the spring** – It would be \$100 per field to have this done. This was denied.

Mr. Yorks, also, stated the tractor shed at the Mexico field needs to have the hinges repaired.
